Minutes of the Full Council Meeting of Boughton Parish Council held on Monday 9<sup>th</sup> November 2015 at 7.00 p.m. in Boughton Village Hall, Butchers Lane, Boughton

#### 15/1459 Apologies for Absence

Apologies were received from Cllrs: Mrs J Shephard and R Wilson. These apologies were approved.

# 15/1461 To sign the Minutes of the last Full Council Meeting held on Monday 12<sup>th</sup> October 2015

The Minutes of the last Full Council Meeting held on Monday 12<sup>th</sup> October 2015 were approved and signed by the Chairman as a true and accurate record.

#### 15/1462 Public Open Forum Session

# 15/1463 Matters arising from the Minutes of the Last Full Council Meeting (not covered by items on the Agenda)

i. <u>Book Exchange Update</u>

The Clerk confirmed that the Book Club had agreed to assist with the Book Exchange once it was up and running. Cllr Potter agreed to obtain a quote for shelving.

ii. Replacement Finger Post Sign – The Green Butchers Lane

The Clerk reported that the wood for the finger post sign had been collected and it had a number of cracks which were not acceptable. Some other posts have been chosen and will be machined ready for installation the week beginning the 16<sup>th</sup> November 2015 although the date is to be confirmed by the contractors.

iii. Land at Chestnut Tree Green

General discussion took place and Councillors resolved that the Parish Council had officially recorded their ownership of the land with the adjacent resident and that this was sufficient protection to prevent a legal prescriptive right being created.

#### iv. <u>Footpath Butchers Lane/Kissing Gate</u>

In the absence of Cllr Mrs Shephard there was nothing to report.

#### v. <u>Staggered Times – Boughton Primary School</u>

Cllr Potter reported that the strip of land adjacent to Boughton Primary School had now been cleared but there were still on-going discussions about who would be responsible for managing the land in the future. Councillors agreed to keep the matter on the Agenda and the Clerk was requested to liaise with the land agents. Cllr Greatorex reported that he had raised concerns with the Head Teacher about the staggered times at the beginning and end of the school day. He confirmed that the school traffic was acceptable in the morning but more of a problem in the afternoon. Cllr Potter agreed to raise this at the next Governors meeting and would report back to the next council meeting on the 11th January 2016.

#### 15/1466 Planning

### a) New Planning Applications

DA/2015/0616 (Amended) Land at Boughton Green Farm, Moulton Lane, Boughton NN2 8RF

<u>Demolition of existing commercial units.</u> <u>Construction of detached dwelling</u> with new access and double garage for existing dwelling

Councillors considered that whilst the height of the building had been reduced the footprint of the building appeared to have increased. As a consequence, the Parish Council maintained their objections to the development on the grounds contained in their previous objection of the 16th September 2015.

# e) Review any matters related to planning applications in preparation or awaiting decisions:

i) <u>DA/2008/0500 Buckton Fields (East) and DA/2011/0666 Buckton Fields</u> (Overall)

**Buckton Fields Local Liaison Forum** 

District Councillor Shephard reported that an initial meeting of the Forum had taken place on Friday 23<sup>rd</sup> October 2015 and draft minutes had been circulated. A direct point of contact had been established with a Joint Project

Manager for the site who was reporting to both developers. All concerns from the development were to be directed through him although David Joseph from Bloor Homes would remain as a default point of contact if matters were not addressed. The Clerk will be the single point of contact for raising any issues. District Cllr Shephard reported that he had prepared a short press release for Boughton Village Matters highlighting what would be happening on the site over the next six months.

Following concerns raised by Cllr Greener regarding the recent highway chaos with the closure of Welford Road coupled with the temporary traffic lights on Brampton Lane the Clerk was requested to raise this with the Joint Project Manager for his consortium meeting on the 10<sup>th</sup> November 2015. Councillors emphasised that this should not be allowed to happen again and that there should have been some co-operation between the developers and NCC Highways.

The Clerk was requested to raise the issue of the damaged verges on Harborough Road North.

The Chairman reported that he had received e-mails from concerned residents in Vyse Road as a property website had located an initial release of properties at Buckton Fields erroneously in Vyse Road. This matter had been raised with the developers and had now been rectified.

- ii) Meeting with Chief Executive of DDC S106 contributions
  - The Chairman reported that he had met with the Chief Executive of DDC on the 6<sup>th</sup> November 2015 and had taken the opportunity to stress the point that the parish had not had a good deal from the S106 Agreement for Buckton Fields.
- iii) Boughton Affordable Housing Allocation

The Chairman reported that affordable housing at Buckton Fields will be allocated on a "cascade" basis, which did not necessarily mean Boughton Parish residents will have first preference. First preference will go to residents in Northampton Borough area.

# d) Budget 2016/2017

A copy of the draft budget proposal and precept figure for 2016/2017 had previously been circulated to all Councillors. District Councillor Shephard suggested that the percentage increase in the precept proposal was too high and recommended increasing the precept by a more acceptable percentage increase. Following discussion Parish Councillors unanimously resolved to amend the budget/precept proposals as follows:-

- i) £2,000 would remain in the budget for Footway Lighting
- ii) £1,000 would remain in the budget for the purchase of a new lap top
- iii) £1,000 would be removed from the budget for the purchase of a Bench Seat
- iv) £600 would be removed from the budget for a Village Day
- v) £3,000 would be removed from the budget for Buckton Fields

- vi) Following agreement by Councillors at the full council meeting held on the 12<sup>th</sup> October 2015 to budget £1,500 for the parish council election in May 2016 Councillors unanimously resolved to now remove £1,500 from the budget for the election. In the event of a contested election Councillors unanimously agreed to meet this cost from General Reserves.
- vii) The Chairman reported that the final budget would be approved at the next full council meeting on the 11<sup>th</sup> January 2016.

#### 15/1468 Highways

a) Boughton Traffic Calming Proposals Update

The Chairman reported that a further on-site meeting had been arranged with NCC Highways on 18<sup>th</sup> November 2015.

b) Highway Warden Scheme

Councillors agreed not to take this initiative forward as the necessity for a Highway Warden was not as urgent. Cllr Potter agreed to continue to monitor the staggered times at Boughton School at the beginning and end of the school day.

c) Highway Grass Mowing 2016

Councillors resolved unanimously to enter into an agreement with Northamptonshire Highways to carry out cutting the grass within the highway for the 2016 grass mowing season. The contribution towards the cost would remain the same as this year at £353.00.

d) Following a question from Cllr Greener the Clerk was requested to ascertain the date of the public consultation for the Northampton Orbital Road scheme. It was believed that this would be before Christmas.
